I am delighted to share some truly heartening news from our recent Board of Directors meeting. In a unanimous decision, the Board voted to define our membership categories to explicitly include spouses, domestic partners, or significant others with whom our primary members cohabitate.

This decision marks a significant milestone in our Yacht Club's history, reflecting our commitment to fostering a stronger, more connected, and truly inclusive community.

For many years, while our partners have been an integral part of our club's social fabric and often active participants in our events, including volunteering countless hours, they have not held formal membership. This update rectifies that for those members who choose to participate, ensuring that those who share our lives and our passion for yachting are fully welcomed into our club family.

This expanded definition of membership will grant our spouses, domestic partners, and cohabiting significant others the rights and privileges of membership. This includes voting rights (one vote per household), access to all club facilities (previously, partners were required to be accompanied by the member on club grounds), inclusion in membership directories, and eligibility to chair committees or run for the board (with the provision that only one person per household may hold a board position at any given time).

We believe this change will strengthen the bonds within our existing membership and encourage even greater participation and engagement across the board.

This decision was made after thoughtful consideration, much deliberation, and the guidance of independent legal counsel, and it reflects the evolving landscape of our society and the diverse nature of our membership.

We recognize that our partners are integral to our lives, often share our love for the water, and contribute significantly to the vibrant spirit of our club. It is only fitting that our membership structure formally acknowledges their importance.

We have a straightforward process for current members wishing to add their spouse, domestic partner, or cohabiting significant other to their membership. All you need to do is contact our Rear Commodore Joe Tanner at Jtanner@tcgstores.com and inform him of your desire to add your partner to your membership. Joe will take it from there.

The Board will work diligently to implement this change smoothly, and our board and staff are ready to assist you. We anticipate that these updates will be reflected in our membership records promptly.

Please join me in celebrating this progressive step forward. I am confident that this enhanced inclusivity will enrich our club and strengthen the camaraderie we all cherish.

## **REAR COMMODORE**



#### JOE TANNER

I am privileged to serve CRYC as Rear Commodore and on the Board. It is an added privilege when the Board steps up to difficult decisions, such as spending \$648,486.00 to replace the fuel system and implement the "Family Membership" Policy, which I am writing to you about today.

I served as Membership Chair for the past two years and was often asked about the club's policy concerning women and family membership. I am also a member of the Portland Yacht Club, and I am often confronted with the comment that CRYC is a "Men's Club." While that may have been true in the past, I do not think it is true today. I see the policy just adopted by the club as a "change whose time has come."

It is my duty to explain the new policy to all members, to let you know what has changed and as importantly, what did not change, and why the Board felt strongly that this action will serve CRYC well in the future.

#### THE BOARD OF DIRECTORS UNANIMOUSLY ADOPTED A "FAMILY MEMBERSHIP" RULE

- Each member may, if they choose, "designate" an adult person with whom they have a "spouse or partner relationship" and "share" their CRYC membership with that person.
- The "family member" must be an adult spouse, registered domestic partner, or partner in a committed cohabitation relationship. It cannot be a child, relative, or friend.
- That "designation" may be cancelled at any time by the admitted or designated member.
- The plan adopted is similar to the long-standing policy of the Portland Yacht Club.
- The Board obtained an independent legal opinion (from one of the largest law firms in Portland) on all aspects of the action, including its consistency with CRYC's Articles, Bylaws, House and Moorage Rules, and practices.

#### WHAT IS NEW

- The new "family member" may be on club property alone and invite guests.
- Participate in the discussions and jointly vote (but only one vote/family).
- Be a committee chair or elected member (but only one/family can be an elected member official at any one time)
- The member may now authorize direct family members to be on club property without them, i.e., adult children may now enter and use or work on the member's boat or boathouse without the member being present.
- It allows family members to designate who will continue with the membership if the family relationship ceases. Essentially, it extends the current survivorship membership as an option for non-married partners when one passes away.

#### WHAT DOES NOT CHANGE

- The dues do not change (only one due).
- This has no effect at all on Men's Night.
- This has no effect on LAC activities or events.
- Only the original member can own water.
- The original member is still responsible for all family members, whether or not they are onsite at the club with them.
- This changes no other membership rules whatsoever.
- The Board does see this as a meaningful change. It will help spouses and partners feel equal and welcome at the club, and it will engage more members in volunteering, contributing, and having fun at our events. This matches our club's desire to be a family club.

Rear Commodore's Article Continued..

#### WHY ANY CHANGE AT ALL

- The last long-range plan found CRYC to be the only yacht club in the area without a family membership, which was found to be a deterrent to attracting new members.
- Members enjoying the club and the revenue from those members are the club's lifeblood.
- CRYC's peak membership was in 2003 with 352 total members (262 full dues-paying members) and has declined ever since. Today, the number of full duespaying members is only 211, and the total number of members (including Salty Dog, Senior, Honorary, etc.) is about 279.
- We have lost 75 members since 2003 and have lost members net over the past three years. The Board believes this policy is a crucial step to increasing membership.

### Shared Family Membership

The Board of Directors has adopted a broadened definition of "Member," allowing the option to include a spouse or partner in a joint "shared family" membership. Couples who choose this option may now share the privileges and responsibilities of a single membership, including voting and holding elected office. Existing members can remain as "individual" members or opt to become "shared family" members. Prospective members will be offered this choice at the time of application.

CRYC was established as a men's club in an era when that was very common. Women have been welcomed as "members" for nearly 20 years, but we have continued interpreting "member" as a single individual. As it turns out, our governing documents don't specifically define "member" as an individual; they were just interpreted that way, which allows the Board to modify that interpretation by resolution.

This has long been a controversial topic. For many, individual interpretation is nostalgic and ingrained in the fabric of CRYC. For others, it is an antiquated notion. More importantly, prospective new members are often repulsed by the expectation to choose a dominant individual in what should be an equal household. Whether factual or not, this idea perpetuates the belief that CRYC is a "men's club," which is unattractive to younger couples who are accustomed to equality.

For existing members, you remain an "individual" member by default. If you would like to share your membership with your spouse or partner, you must designate in writing to the Rear Commodore (via the office). You may also designate who will retain the CRYC membership should the relationship end. If no designation is made, the Board would decide who to keep.

If you elect to share your membership, you will have one vote as a couple. Either may be elected to the Board, but only one at a time. Spouses have previously served on committees, but the change clarifies that either may serve as committee chairs. For many, there won't be many practical implications.

For those not legally married, shared family membership ensures your partner continues as a member in the event of your demise, avoiding a new initiation fee applicable in the past.

The new rule also allows members to authorize their family members to be on-site without them for up to one year. The member remains liable for all actions of the other family members.

Together, these actions encourage robust family participation at CRYC.

## BOARD MINUTES OVERVIEW April 17th, 2025

The full meeting minutes can be found in the link tree.

Commodore Lance called the meeting to order. Approximately 21 members attended either in person or virtually. All board members were in attendance or provided a proxy.

### **STANDARD REPORTS:**

- □ The March Board minutes were approved.
- □ The February financial report was presented. The March financial report will be presented in May, and approval of both the February and March financial statements was delayed until May.
- Commodore Kirk presented a brief report on measures being taken to allow the Paddlefish to be used this cruise season, with a haul-out scheduled for the fall.
- □ Commodore Kirk announced the establishment of an ad hoc Sunshine Committee to be chaired by Gloria Almroth. The Board ratified that announcement by a unanimous vote.
- Mr. Spargo reported that the boathouse fire safety inspections have been completed, and that letters to members and other corrective actions are underway.
- □ Mr. Spargo reported of excessive contaminated fuel dumping in the oil collection containers in the trailer storage lot. Certain corrective measures were discussed.
- Mr. Spargo requested an amendment to the House & Moorage Rules, which was adopted by the Board. Henceforth, a fire detection system will be required in any "enclosed area" of a boathouse, not solely in an "apartment".
- □ Vice Commodore Sutherland reported on the progress of the fuel system replacement. It appears the project is on schedule and on budget, and that the contractor is doing a very good job.

#### ACTION ITEMS:

- A resolution and House & Moorage Rule change related to family membership was moved, seconded, discussed at length, and unanimously adopted. Copies of the resolution and rule change are available at the club office.
- Membership Committee Chair Francisco Rivera recommended to the board that Max McCuddy and Kirk Hall be approved as Social Members, and that the resignation of Stephen Blum and Dave Burton be approved. The recommendations were duly moved and seconded and approved unanimously.
- Moorage Chair Matt McCuddy recommended to the board that the sale and transfer of the water rights to slip C-07 from Joe Tanner to Melvin Cooper, and the water rights to slip E-11 from Stephen Blum to Joe Tanner be approved. The motions were approved unanimously.
- Steve Strong requested an additional \$4,000 for concrete work and other improvements out to the peninsula, with the help of member volunteers. A motion to approve the additional amount was unanimously approved.

ADJOURNMENT: The meeting was adjourned by the Commodore. The next board meeting will be held on May 15, 2025.
